ABOUT THE FUND

The Fisher Funds New Zealand Growth Fund is our flagship fund and was launched in August 1998. The fund focuses on growth of your investment over the long term by investing in quality New Zealand companies which can consistently produce increasing earnings. Typically the fund will be invested in 15 to 20 companies at any one time. Often a company in the fund will have been chosen because it offers a unique product or service, has a dominant market position or brand, or operates in a fast growing sector.

FUND HIGHLIGHTS

February 2023

The New Zealand portfolio fell by -0.6% in February, matching the local market return of -0.6% (S&P/NZX 50).

The fund's largest position **Mainfreight** (+2%) delivered a relatively solid trading update for the first 43 weeks of its financial year, through to the end of January 2023. Growth is slowing, which is consistent with what is happening in the global economy, but the company is still performing credibly versus what was a very strong period in the previous year.

Retirement village operator **Ryman Healthcare** (-19%) raised \$902 million from issuing new shares at \$5.00 to repay its US Private Placement debt in full. We had anticipated the equity raising, given the unexpectedly large step-up in debt level revealed in November, and had reduced our position at higher prices. We took up our entitlement in the offer, as the company has taken the first steps to set itself on a more sustainable growth trajectory, and the long-term economics of the business model remain compelling. Our shareholding remains smaller than previous years until we get more confidence in the new path forward.

Oyster Bay wine producer **Delegat** (-9%) reported its first half result through to December, which showed modest +2% profit growth on the prior year on case sales up +4% as cost growth weighed on performance. Full year profit expectations were tempered to \$59-62 million (from \$60-64 million), versus \$58.1 million the previous year. During tropical cyclone Gabrielle, the company experienced some minor surface flooding at its Hawkes Bay winery and one of its vineyards, although has seen no silt residue, and expects no damage to vines or impact on the upcoming harvest

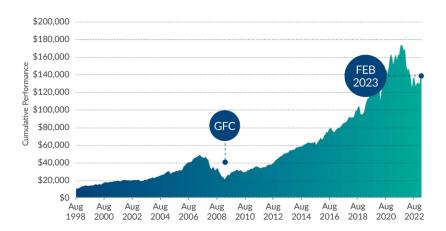

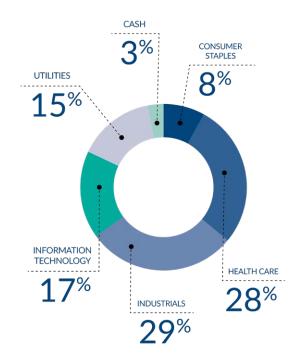
